Personal data handling

This information has the scope to allow the users to know, even before to access to the various sections of the site and give their data, how BRAMBATI S.p.A. will handle the personal data of users and will be necessary for the user takes vision before he gives his personal data by completing the appropriate spaces in the various sections of the site.

Purpose of treatment

According to the requirements from time to time expressed by the user who accesses to the various sections of the site, the purposes of processing of personal data conferred directly to users by completing the forms online will be as follows:

- a) allowing registration on the site, which is necessary for access to particular sections of the site itself and to deliver and manage the various services offered;
- b) prior consent of the users and until the withdrawal of the same, carry out marketing activities (which, being merely limited but not exhaustive, sending promotional material and advertising, conducting related analysis on registered users, enabling BRAMBATI S.p.a. measures to improve services and products offered to its customers), and even by e-mail, fax, sms and mms, with the specific consent and until the withdrawal of the same;
- c) promoting initiatives of marketing and advertising for which will however, and every time, the opportunity to object, demanding the cancellation of your mail from those which are targeted these messages;
- d) to send newsletters to receive updates on all the latest news from the site,

recipes, menus, nutritionist tips and many other news on the BRAMBATI Group;
e) respond to user requests related to BRAMBATI products, advertising, of the site (area "Contact" on the site);
f) allow a free exchange of information among those persons who consult the site ("Blog" section).

Handling of treatment

Personal data will be processed in a mostly automated form, with logic closely related to those objectives.

Nature of providing personal data of users

The conferment of personal data is optional, but it is partly needed (that's why some data boxes are marked with an asterisk) to BRAMBATI S.p.A. can meet the requirements under the functionality of the site.

The failure, partial or inaccurate conferment of personal data marked with an asterisk, as necessary to execute the requested service, does not make this execution possible; while the failure, partial or inaccurate conferment of personal data optional unnecessary has no consequence.

Categories of personal data subject to treatment

In addition to personal data submitted directly by users (such as name, postal address, e-mail, etc.) during the connection phase to the web site, computer systems and software procedures for running the site itself indirectly acquire some personal data whose transmission is implicit in the communication protocols of the Internet.

These data are processed solely for purpose of anonymous statistical surveys.

Categories of persons who may be aware of users personal information

The personal data can be brought to the attention of employees or employees of the sales department of the owner who, working under the direct authority of the owner are appointed or persons in charge of treatment under Articles. 29 and 30 of the Code and will receive about appropriate operational instructions; the same will happen - by managers appointed by the owner - against employees or employees of Managers.

Area of communication or distribution of personal data of users

Manager in charge of the data

Responsible of personal data under Article 29 of the Code is Dr. Andrea Brambati.

The rights recognized by users Article 7 of the Code

"Article 7 - The right of access to personal data and other rights

1. A person have the right to obtain confirmation of the existence of personal data concerning him, even if not yet registered, and their communication in an clear and simple form.

2. The user have the right to be informed:

- a) the source of personal data;
- b) the purposes and methods of treatment;
- c) the logic applied in the case of processing with electronic instruments
- d) the identity of the processors and the appointed representative on the Italian state, if any;
- e) the subjects or categories of persons to whom the data may be distributed or who may come to know them as appointed representative of the Italian State, managers or agents.

3. The user has the right to obtain:

- a) updating, correction or, if interested, the integration of data;
- b) the cancellation, transformation into an anonymous form or block of data processed in violation of law, including those which are not required to be held for the purposes for which the data were collected or subsequently processed;
- c) confirmation that the operations mentioned in previous letters a) and b) have been notified, including with regard to their content, to those whose data were disclosed or distribution, unless this requirement is impossible or involves a manifestly disproportionate to the protected right.

4. The individual has the right to object in whole or in part:

- a) for legitimate reasons, the processing of personal data, even if related to the purpose of collection;
- b) the processing of personal data for the purpose of sending advertising material or direct sales or for carrying out market research or commercial purposes. The exercise of the rights referred to above can be exercised directly or giving, in writing, delegate or attorney to individuals or associations.
